

ORDINANCE NO. 2010-893

AN ORDINANCE OF THE CITY OF DEER PARK, WASHINGTON, AMENDING THE 2010 ANNUAL BUDGET, AS ADOPTED IN ORDINANCE 2009-884. THIS AMENDMENT IS TO INCLUDE THE GENERAL RESERVE, CAPITAL IMPROVEMENT, WATER IMPROVEMENT, WASTEWATER IMPROVEMENT AND GOLF COURSE FUNDS.

WHEREAS, certain changes needed to be made to the 2010 budget and are deemed to be in the best interest of the citizens of the City of Deer Park, and

WHEREAS, it is necessary to reflect these changes in the budget for the above mentioned funds due to unforeseen expenditures.

Section 1. The uses in the annual city budget for the year 2010 as set forth in Ordinance 2009-884 are amended as follows:




