

ORDINANCE NO. 2010-894

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF DEER PARK, WASHINGTON, ADDING A NEW SECTION 3.24.160 TO THE DEER PARK MUNICIPAL CODE; ADDING A GOLF COURSE FUND; AND SETTING AN EFFECTIVE DATE.

**WHEREAS**, pursuant to action approved by the City Council, the City purchased the Deer Park Golf Course; and

**WHEREAS**, as a result of the purchase of the Golf Course, it is necessary for the City to have a fund to identify revenue and expenditures related to the purchase, operation, and maintenance of the Golf Course; and

**WHEREAS**, the City Clerk/Treasurer has suggested that this fund be identified as the Golf Course Fund 406 and the Mayor and City Council concur with this recommendation; NOW, THEREFORE

THE CITY COUNCIL OF THE CITY OF DEER PARK, WASHINGTON DO ORDAIN AS FOLLOWS:

**Section 1.** A new Section 3.24.160 is hereby added to the Deer Park Municipal Code to read as follows:

**3.24.160 Golf Course Fund.**

There is established in the office of the Treasurer of the City of Deer Park a fund known as Fund 406 titled "Golf Course Fund," which fund is created for the purposes of deposit and withdrawal of funds related to the purchase, operation, and maintenance of the Deer Park Golf Course.

**Section 2. Effective Date.** This Ordinance shall take effect and be in full force five (5) days after this ordinance or a summary thereof consisting of the title is published.


