

**ORDINANCE NO. 2011-913**

**AN ORDINANCE OF THE CITY OF DEER PARK, WASHINGTON, AMENDING THE 2011 ANNUAL BUDGET, AS ADOPTED IN ORDINANCE 2010-902. THIS AMENDMENT IS TO INCLUDE THE AIRPORT FUND.**

**WHEREAS**, certain changes needed to be made to the 2011 budget and are deemed to be in the best interest of the citizens of the City of Deer Park, and

**WHEREAS**, it is necessary to reflect these changes in the budget for the above mentioned fund due to unforeseen revenues and expenditures.

**Section 1.** The uses in the annual city budget for the year 2011 as set forth in Ordinance 2010-902 are amended as follows:




