

ORDINANCE NO. 2013-935

AN ORDINANCE OF THE CITY OF DEER PARK, WASHINGTON, AMENDING THE 2013 ANNUAL BUDGET, AS ADOPTED IN ORDINANCE 2012-918. THIS AMENDMENT IS TO THE CIVIC IMPROVEMENT, CAPITAL IMPROVEMENT, WATER, WASTEWATER, WATER IMPROVEMENT, WASTEWATER IMPROVEMENT, AIRPORT, AIRPORT GRANT AND EQUIPMENT REPLACEMENT RESERVE FUNDS.

WHEREAS, certain changes needed to be made to the 2013 budget and are deemed to be in the best interest of the citizens of the City of Deer Park, and

WHEREAS, it is necessary to reflect these changes in the budget for the funds identified in section 1 of this ordinance due to unanticipated revenues and expenditures.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF DEER PARK, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. The appropriations in the annual city budget for the year 2013 as set forth in Ordinance 2012-918 are amended as follows:

Section 2. This ordinance shall take effect and be in full force five (5) days after this Ordinance or a summary thereof consisting of the title is published.






