

ORDINANCE NO. 2015-958

AN ORDINANCE OF THE CITY OF DEER PARK, WASHINGTON, AMENDING THE 2015 ANNUAL BUDGET, AS ADOPTED IN ORDINANCE 2014-950. THIS AMENDMENT IS TO THE STREET FUND, LTGO BOND, WATER, WASTEWATER, WASTEWATER IMPROVEMENT, AIRPORT, AIRPORT GRANT AND EQUIPMENT RENTAL REPLACEMENT RESERVE FUNDS.

WHEREAS, certain changes needed to be made to the 2015 budget and are deemed to be in the best interest of the citizens of the City of Deer Park, and

WHEREAS, it is necessary to reflect these changes in the budget for the funds identified in section 1 of this ordinance due to unanticipated revenues and expenditures.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF DEER PARK, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. The appropriations in the annual city budget for the year 2015 as set forth in Ordinance 2014-950 are amended as follows:


