

ORDINANCE NO. 2013-931

AN ORDINANCE OF THE CITY OF DEER PARK, WASHINGTON, AMENDING SECTION 12.04.100 OF THE DEER PARK MUNICIPAL CODE TO CORRECT REFERENCES TO THE CITY FOR ROAD DEVELOPMENT STANDARDS IN THE CITY; AND SETTING AN EFFECTIVE DATE.

WHEREAS, City staff have reviewed the road development standards for construction of roadways in the City of Deer Park (“City”) set forth in Chapter 12 of the Deer Park Municipal Code (“DPMC”), and determined that Section 12.04.100 DPMC contains a reference to Spokane County, rather than the City; and

WHEREAS, the City staff recommend, and the City Council concurs, that Section 12.04.100 DPMC should be amended to correct the erroneous reference to the County; and

WHEREAS, the City Council has determined that adoption of this Ordinance is in the best interests of the public health, safety and welfare of the citizens of the City of Deer Park; NOW, THEREFORE,

THE CITY COUNCIL OF THE CITY OF DEER PARK, WASHINGTON DO ORDAIN AS FOLLOWS:

Section 1. Section 12.04.100 of the Deer Park Municipal Code is hereby amended to read as follows:

12.04.100 Roads – Authority to develop and administer standards.

The community services director is authorized and directed to develop standards for building roads within the city and to administer the same. As a minimum, such standards shall include:

- A. Drawings showing typical roadway sections.
- B. Horizontal and vertical alignment requirements.
- C. Specifications for roadway design and pavement type.
- D. Specifications for safety features, traffic control, sidewalks, and other appurtenances.
- E. Drainage control requirements.
- F. Private road requirements.

Section 2. This Ordinance shall take effect and be in full force five (5) days after this Ordinance or a summary thereof consisting of the title is published.


