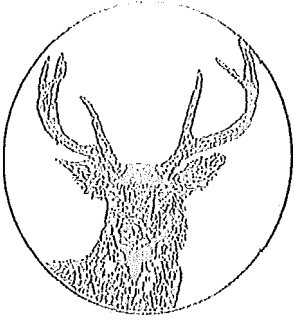

## Welcome to the City of Deer Park!

We are glad that you have chosen the City of Deer Park as your place of residence.

This letter will provide you with information regarding garbage service, dog licenses, electric and gas service, cable television, telephone and water/sewer service.

- All occupants and/or owners of a premise must have garbage service (ordinance 8.12.110). **Garbage service** is provided contractually by Waste Management. To set up a service account with Waste Management, please call their office at 509-924-9400. If you have any questions regarding garbage service, please direct your questions to Waste Management.
- **All dogs & cats must be licensed through SCRAPS.** Pet Licenses can be purchased at City Hall, Online or through the mail. Animal control question or concerns, please contact SCRAPS at 509-477-2532.
- The primary Electric and gas provider is **Avista Utilities** at **1-800-227-9187**.
- The primary phone provider is **Lumen** at **1-800-777-9594**
- **Utility rates for the City of Deer Park are as follows:**  
\$92.18 is the monthly minimum utility bill. This amount gives 4,000 gallons consumption allowance and is charged \$.83 per thousand gallons thereafter. Bills are mailed the last working day of the month & are due by the 15<sup>th</sup> of the following month.  
Utility bills become delinquent at 30 days past due & a delinquency fee of \$26.00 will be charged to the account. If delinquent amount is not paid by the date indicated on the notice, water service will be terminated & an administrative fee of \$32.00 will be assessed. Once water services are terminated all charges & fees must be paid in full before services will be reinstated.
- **Low-income seniors** or **low-income disabled utility discount forms** can be picked up at City Hall.
