

**ORDINANCE NO. 2017-972**

**AN ORDINANCE OF THE CITY OF DEER PARK, WASHINGTON, AMENDING THE 2017 ANNUAL BUDGET, AS ADOPTED IN ORDINANCE 2016-965. THIS AMENDMENT IS TO THE STREET, ARTERIAL STREET, CIVIC IMPROVEMENT, WATER, WATER IMPROVEMENT, GOLF COURSE, AIRPORT, AND AIRPORT GRANT FUNDS.**

**WHEREAS**, certain changes needed to be made to the 2017 budget and are deemed to be in the best interest of the citizens of the City of Deer Park, and

**WHEREAS**, it is necessary to reflect these changes in the budget for the funds identified in section 1 of this ordinance due to unanticipated revenues and expenditures.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF DEER PARK, WASHINGTON, DO ORDAIN AS FOLLOWS:**

**Section 1.** The appropriations in the annual city budget for the year 2017 as set forth in Ordinance 2016-965 are amended as follows:

**Section 2.** This ordinance shall take effect and be in full force five (5) days after this Ordinance or a summary thereof consisting of the title is published.






