

**ORDINANCE NO. 2021-1004**

**AN ORDINANCE OF THE CITY OF DEER PARK, WASHINGTON, AMENDING THE 2021 ANNUAL BUDGET, AS ADOPTED IN ORDINANCE 2020-997. THIS AMENDMENT IS TO THE 2014 LTGO BOND FUND, CIVIC IMPROVEMENT FUND, FACILITIES CAPITAL IMPROVEMENT FUND, WATER FUND, AIRPORT FUND.**


**Section 1.** The appropriations in the annual city budget for the year 2021 as set forth in Ordinance 2020-997 are amended as follows:


